# Access to Memory (AtoM) enhancements

In the last funding cycle of Library and Archives Canada's Documentary History Communities Program (DHCP), CCA applied and was successful in its application for funding to enhance the bulk import/export features for the open source software AtoM (Access to Memory), which is the platform for the national catalogue of archival descriptions, ARCHIVESCANADA.CA, and numerous regional and local archival catalogues. In addition to DHCP, our partners on this project are: the Archives Association of British Columbia (aabc.ca), the Council of Nova Scotia Archives (councilofnsarchives.ca), the Nova Scotia Archives (archives.novascotia.ca), the Simon Fraser University Archives and Records Management (sfu.ca/archives), the University of Saskatchewan University Archives and Special Collections (library.usask.ca/archives), the University of Victoria Special Collections and University Archives (uvic.ca/library), and the United Nations (un.org/en).

Once development is completed these features will be incorporated into AtoM software version updates. These enhancements will enable large amounts of metadata to be transferred from legacy databases to AtoM, from local instances of AtoM to regional and national AtoM-based catalogues, and between AtoM and other digital curation platforms. Bulk import/export functionality will also enable future transfer of metadata to new technical platforms, as required. Work is currently underway by Artefactual Systems on the features supporting these functionalities, to be followed by a review by CCA, with an expected completion of January 2017.

# **ARCHIVESCANADA Digital Preservation Service (ACDPS)**

The last funding cycle of DHCP also saw the successful approval of CCA's subscription-based bilingual *Archives Canada Digital Preservation Service (ACDPS)*. ACDPS will provide institutions access to a preservation service maintained in an optimised technological environment. Governed through CCA, participating institutions will be able to preserve small or large digital collections using the popular open-source, standards-compliant Archivematica and AtoM tools. Archivematica and AtoM software hosting services will be provided in partnership with Artefactual Systems Inc.

Archivematica is a suite of open-source tools designed to perform specialized preservation actions on digital objects and to prepare Archival Information Packages for long-term storage. Archivematica automates processes that are well beyond the capabilities of most organizations to perform manually, and generates highly-detailed metadata in standard XML schemas. The system includes out-of-the-box support for hundreds of file formats and provides a framework for adding support for new formats over time.

#### ACDPS benefits include:

- achievement of a solution for one of the most pressing issues confronting technologydriven organizations: preservation of accessible, authentic and reliable digital records
- access to professional specialists with expert knowledge supporting implementation and use of the Digital Preservation Service (DPS)
- realization of economies of scale through pooling and leveraging of financial, technical and human resources
- availability of services in both French and English
- availability of a fully Canadian-based and operated DPS solution compliant with Canadian law
